Executive Summary

A Message from our Co-Founder & Vice President

Sustainability focuses on meeting the needs of the present without compromising the needs of future generations. Living 100% sustainable is not easy and arguably may not be possible with current technology. However, it

should be the goal of every individual to live in a matter that does not compromise the future, and leave the world a better place than when we arrived. To ensure this is a priority of every employee of Mazza Recycling, our mission statement states the following:

"Our mission is to provide exceptional waste collection, recycling, and disposal services in a cost effective, safe manner while protecting and improving the environment in the communities we serve."

The purpose of this report is to share our sustainability efforts, which we hope to continue to build upon in the future as we work towards a greener tomorrow.

Recycling is essential to long-term, global sustainability. In 2019, after years of due diligence and research, we have committed to building the most state-of-the-art single stream recycling plant at our recycling facility in Tinton Falls, New Jersey. This plant will be the first complete positive sorting design on the east coast and is set to open in September 2020. This additional recycling capacity extends the life cycle of plastics, paper, cardboard, and metal containers, while also keeping these materials out of landfills. Furthermore, utilizing recycling materials in the production of new products conserves trees and natural resources. Additionally, we have learned the energy to produce new products from recycled materials is less than producing from virgin materials.

It should be the goal of every individual to leave the world a better place than when we arrived.

To further our commitment to sustainability, we created the Greener Tomorrow Program, a community-wide initiative that seeks to be an advocate and resource for local students to learn about recycling. This program is designed to bring environmental education to schools, organizations, and communities, spreading the message that recycling is our future and demonstrates the proper methods of recycling.

It is our hope that through these programs and initiatives, we can lead the way to a greener tomorrow.

and produce quality products that will have consistent movement in an increasingly restrictive global market. By investing in this design, Mazza seeks to not only preserve natural resources, but also to extend the life-cycle of plastics, paper, cardboard, and metal containers in a world undergoing an environmental crisis. 


GROWTH FROM 2015-2019

2019 At A Glance...

Renewable Energy

We generated 300,600 kilowatt-hours of renewable energy at our facilities from solar arrays, which is enough power to meet the annual electricity demand of nearly 36 households.



350,000 tons

We processed 350,000 tons of recyclable materials, marketing more than 50 different commodifies including scrap metal, aggregates, organics, bulky and C&D waste, and residential & commericial paper, glass, and plastics.



Our 2019 recycling services saved the following amounts of energy which translates to each of the following (*per EPA WARM):

17,508 Household Annual Energy not consumed

276,080 Barrels of oil not consumed

13,316,710 Gallons of gasoline not consumed



We maintained 47 acres of natural space at our facilities, including species habitat and forest, 47 acres and wetlands.

We accepted 550,000 cubic yards of organic material to produce ten varieties of nutrient rich compost and mulch, including **IPEMA** Certified Playground Safety Surface and Natural Oraanic Hardwood Mulch.

Recycling Education

A Greener Tomorrow

Mazza Recycling provides comprehensive recycling education and outreach to our local communities, with the goal of teaching current and future generations the importance of recycling. We do this by providing programming designed to encourage sustainability in the form of tours, community tabling & events, and in-school presentations. The program is custom tailored to best serve the needs of our local residents, customers, schools, educators, and organizations.

PRESENTATIONS

Presentations are facilitated by an educated member of the Mazza team, and custom made so that students and adults of all ages can learn about complex recycling systems in a fun and engaging, easy-to-understand, hour-long experience. Our facilitators would provide participants with take away materials that allow them to continue the recycling conversation at home, and with their peers.

TABLING & EVENTS

Mazza Recycling is an active participant in community events including festivals, parades, fairs, and Earth Month celebrations. At these events, our teams engage the public, often answering questions about proper disposal of specific materials, like recyclables or bulky items. Our teams come prepared with interactive sorting games and eco-friendly giveaways that promote recycling and waste reduction.

TOURS

Mazza Recycling welcomes aroups to tour many of our facilities, including our recycling and organics processing operation, transfer station, and single stream recycling facility to provide an inside look at recovery and sorting operations. Our team regularly hosts tours for school groups and commercial businesses, community groups, product designers, and industry professionals interested in learning how their actions impact the recycling process.







2019 Safety Report

A culture of safety is a top priority at Mazza Recycling and is proven by the high level of dedication by our employees. The proper safety process goes beyond what the typical thoughts of safety encompass. Having proper personal protective equipment (PPE) and safety programs are only the tip of the iceberg. 

TRUCK SAFETY

Mazza Recycling has invested in two programs that ensure the safe operation of the vehicle by the driver, and the proper maintenance of the vehicles in the shop, to prevent failures on the road. Forward facing cameras are used in our trucks to audit our drivers safety. We will utilize that data to coach our drivers to improve their safe driving. Mazza maintains a high level of safe driving as shown in our safety score of 97.

EMPLOYEE SAFETY

Individual employee safety is a top priority at all times. This is shown by the year over year trend of lowered rates of injury. Mazza recycling utilizes state-of-the-art training methods and materials to ensure the understanding of all policies and procedures in three different languages. These trainings include online and in-person training.
